## LIABILITY WAIVER

In consideration of the agreement of Alameda County Industries and/or its affiliates (“ACI of San Ramon”) to enter onto the premises of the undersigned described below with ACI of San Ramon’s vehicles and equipment to collect garbage and/or recycling materials, the undersigned does hereby agree to forever release and save harmless ACI of San Ramon and its shareholders, officers, directors, agents, affiliates, insurers and successors from and against any and all claims, damages, actions, causes of action, costs and expenses (including attorney’s fees) relating to damage to pavement or driving surfaces on such premises which may arise in any manner out of or in connection with the entry or operation on, or egress from, such premises by ACI of San Ramon’s vehicles and equipment.

The undersigned also acknowledges, and waives to the maximum extent permitted by law any rights or benefits the undersigned may have under, Section 1542 of the California Civil Code, which provides as follows:

“A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor.”
