Proper Sorting Makes a Difference! (and it's the law)

USE YOUR CONTAINERS TO SORT YOUR WASTE FOR:

- Compliance with California regulations AB341, AB1826, and SB1383.
- A reduction in the amount of material going to the landfill. Of the 39 million tons of waste disposed of in California landfills in 2018, one third was compostable materials.
- A reduction in greenhouse gas emissions. Anaerobic decomposition of organic materials in landfills produces methane (CH4), a greenhouse gas that contributes to pollution and global warming. Composting organic material sequesters carbon and reduces greenhouse gas emissions.

California Regulations Require Recycling and Composting.

Maintain Smoke Detectors & Carbon Monoxide Alarms

☑ Test existing detectors/alarms.



- \checkmark Install new batteries and properly recycle the old ones.
- Remove non-working detectors/alarms and install new ones.
- Dispose of non-working detectors/alarms responsibly.

- Many manufacturers offer a mail-in program for smoke detectors/alarms. Refer to the product label, user's manual, or warranty for manufacturer's instructions.

- Bring your non-working detectors/alarms to Contra Costa County's Household Hazardous Waste drop-off facility. More info is available by calling (800) 646-1431 or visiting www.sanramon.ca.gov/hhw

Please Remember NØ Sharps!

Sharps (needles, scapels, blades, & lancets) are NOT allowed in any ACI of San Ramon collection container. Ask your doctor or pharmacist about

available disposal options. Sharps may be also disposed of at the San Ramon Valley Fire District's Administrative Office, at 1500 Bollinger Canyon Road, San Ramon. The drop box is outside the front door and is accessible 24/7.

Collection service schedule will **NOT** change during the week of Presidents' Day.



You Can Minimize Water Pollution

Keep the creeks, rivers, the Delta and the Bay clean and healthy. Follow these tips:

• If your tenants can change their own oil, make sure they contain and recycle used oil and filters properly.

- Place litter in the correct collection container and make sure the lid is fully closed.
- Prevent leaves from getting into storm drains and place them in your green **organics** container(s).
- Avoid applying fertilizers and pesticides, especially if rain is forecast.
- Check parking areas for fluid leaks. If a car is leaking, have the owner use a drip pan and arrange repair.
