

Remove your address from direct mail registries at www.directmail.com/mail\_preference. Discontinue unwanted catalogs at CatalogChoice.org. Prevent auto phonebook deliveries at YellowPagesOptOut.com.

STOP SINGLE-USE HABITS. CHOOSE REUSABLES. Make it a habit to use travel mugs, reusable water bottles, and shopping bags/totes.

BEFORE YOU REPLACE AN ITEM, SEE IF IT CAN
BE REPAIRED. And if you do purchase something
new, find the highest quality/longest lasting option possible.

# Sort Your Waste Correctly!

Make sure everyone in your household knows what material goes in which cart.

Food scraps and food-soiled paper belong in your ORGANICS cart.

Keep it clean, keep it loose.

Make sure recyclable plastic, metal, and glass food containers are empty and dry before placing them in the RECYCLABLES cart.

Please do not bag your recyclable items.

Styrofoam®, plastic wrap, and non-recyclable packaging belong in your GARBAGE cart.

Scan the QR code for a searchable list of what



goes where and a virtual video tour to find out what happens to your recyclables after they are collected.



### A Message to Our Customers

We recently received an anonymous complaint that the proper sorting graphics on our carts and the associated outreach materials (brochures, billing inserts, etc.) is too good. This customer stated that they did not need to be reminded of what goes where and how to properly sort their waste because they already do it.

As an FYI - the graphics on the carts and bins and our outreach materials are a state-mandated requirement per California Senate Bill 1383 (SB 1383). Even the frequency with which we inform residents that recycling and organics participation is mandatory is dictated by SB 1383. So, if you haven't yet seen it statewide yet, you soon will.

So, to our customer who anonymously lodged this complaint, thank you for properly sorting! For those of you still uncertain about what goes where we

hope you find our image-based, color-coded carts with QR codes on the container labels that send you to our website, helpful. And to all of our customers, we thank you for your efforts to help keep our community clean and green!

## Household **Hazardous Waste** (HHW) Disposal

#### Remember, NØ Sharps!

"Sharps" is a medical term for devices with sharp points or edges that can puncture or cut skin such as needles, syringes, lancets, auto injectors (such as EpiPens), and infusion sets.

- Ask your pharmacist about available disposal options.

**Use the Clean Harbors HHW** door-to-door (D2D) collection service at no additional cost to you! Clean Harbors provides an appointment-only service to remove difficult-to-dispose of materials like household batteries, chemicals, paints, e-waste, and fluorescent lamps directly from residents' doorsteps.
