Do You Have Household Hazardous Waste (HHW) at Your Complex?

Make Sure to Dispose of it Properly!

Use the Clean Harbors HHW door-to-door (D2D) collection service at no additional cost!

- The property manager/owner must make an appointment on the tenants' behalf.
- The property manager will work with Clean Harbors staff to designate an area to collect HHW at the complex.

Maintain Smoke Detectors & Carbon Monoxide Alarms

- Test existing detectors/alarms.
- Remove non-working detectors/alarms and install new ones.
- Install new batteries (*if applicable*). Properly dispose of the used batteries.
- Dispose of non-working detectors/alarms responsibly.* Many manufacturers offer a mail-in program for smoke detectors/alarms. Refer to the product label, user's manual, or warranty for manufacturer's instructions.



*PLEASE NOTE: Clean Harbors does not collect ionizing or ionization smoke detectors, as these contain a small amount of radioactive material. Look for a radiation symbol as shown here:

NØ sharps or unwanted/expired medications in ACI collection bins!

"Sharps" is a medical term for devices with sharp points or edges that can puncture or cut skin such as needles, syringes, lancets, auto injectors (*such as EpiPens*), and infusion sets. Disposing of medications down the toilet, drain or in the garbage (*residential or commercial*) is harmful to the environment.



- Sharps, pharmaceuticals, and unwanted or expired medications may be disposed of at the **San Ramon Safety Complex** at 2401 Crow Canyon Rd. The drop box is located in the lobby and is accessible Monday – Friday, 8 am – 5 pm, and is closed on weekends. Sharps and pharmaceuticals are only accepted for disposal during business hours. **DO NOT leave sharps, pharmaceuticals, or medications outside the Police Department's front door when the business office is closed.**

California Regulations Require Recycling & Composting*

California Senate Bill 1383 requires that multi-family residences **MUST SORT RECYCLABLES & ORGANIC MATERIAL OUT OF THE GARBAGE** and subscribe to adequate levels of service for recyclables, organics, and garbage. Each multi-family complex in San Ramon has been provided with Recyclables and Organics service containers. Need to change your current service level? The ACI of San Ramon Sustainability Specialists are available to visit your complex to conduct waste assessments, make service suggestions, help train and give presentations to employees and tenants, and provide materials to assist your tenants with proper sorting and waste reduction.

- The Recycling Tote is to transport recyclables to the blue recycling collection containers at your complex.
- The Handy Kitchen Pail is for the collection of food-soiled paper and food scraps. Tenants simply empty the contents of the pail into the green bins at your complex. Find more info by visiting SanRamonRecycles.com/stopwastingfood
